

## YTM 2025 Tax Checklist for Individual Tax Return Form 1040

### Basic Information

- ☐ Full name, SSN, address, and date of birth for you, spouse, and your dependents
- ☐ Copy of your 2024 tax return
- ☐ Bank account & routing number for direct deposit (refund) and debit (tax payment)
- ☐ Multi-state and foreign residence information if moved during the year or earned income from other states and/or countries.

### Income

- ☐ W-2 forms
- ☐ 1099-NEC and 1099-MISC (business and other types of income)
- ☐ 1099-INT, 1099-DIV, 1099-B (security trades, etc.) or Consolidated Statement
- ☐ 1099-R, SSA-1099 (retirement income)
- ☐ 1099-G (unemployment, state or local tax refunds)
- ☐ 1099-S (sale of property) and 1099-C (Cancellation of debt)
- ☐ Sale of main residence – purchase and sale closing statements
- ☐ Miscellaneous income: jury duty, gambling winning (W-2G), MSA/HSA distributions (1099-SA), scholarships, hobby income, alimony received (divorce date).
- ☐ Foreign income: foreign W2 equivalents, contractor income, investment income, retirement income.

### Business Income

- ☐ K-1 (S-Corporation, Partnership, Estate/Trust) and AZ form 355 (if applicable).
- ☐ Schedule C (Self-employment Income) – income & expenses information, benefits, etc.
- ☐ Schedule E (Rental Property and Royalty Income) – income and expenses information
- ☐ Schedule F (Farm Income) – income & expenses information, benefits, etc.

### Adjustments to Income

- ☐ IRA, SEP IRA, SIMPLE, 401K, etc. retirement contributions information
- ☐ Teachers Expenses – expense information
- ☐ 1098-E student loan interest deductions
- ☐ HSA contribution deduction Form 8889, MSA deduction
- ☐ Self-employed health insurance payment information
- ☐ Foreign Income
- ☐ Alimony payment (Divorce date, recipient name & SSN)
- ☐ Foreign Income & Housing Deduction form 2555
- ☐ Other adjustments

### Itemized Deductions (Schedule A)

- ☐ Medical & dental expenses, healthcare insurance
- ☐ Form 1098 (mortgage interest, PMI, and real estate tax payment information)
- ☐ Real estate tax paid.
- ☐ Personal property taxes paid – vehicle license fees/taxes based on value.
- ☐ State and local taxes, foreign taxes paid.
- ☐ Charitable contributions – receipts and details, and separately tallied by cash or goods donations, mileage
- ☐ Gambling expense details to offset the gambling income reported on W-2G.
- ☐ Investment interest expenses

### Other Credits and Deductions

- ☐ Childcare costs while parents working or in school. Name. address, EIN and amount.
- ☐ Education costs: Form 1098-T, itemized other education expenses.
- ☐ Adoption costs: SSN and detailed legal, medical, transportation expenses.

### Other Information

- ☐ Estimated tax payments (1040ES) federal information and states information.
- ☐ Prior-year refund applied to current year
- ☐ Extension filing payments.
- ☐ Asset distributions from an estate, domestic or foreign.
- ☐ FBAR – Foreign Bank Account Reporting information.
